

TERMS AND CONDITIONS FOR THE WESTFIELD WIN THE ULTIMATE CHRISTMAS HAMPER PROMOTION 2009

1. The promotion starts at 9am on Monday 16th November 2009 and concludes when each participating Westfield centre closes for trade on Sunday 29th November 2009 (Promotion Period). Entries received after this closing time will be ineligible for entry.
2. Each purchase receipt for a single purchase of \$50.00 or more made in a participating Westfield centre during the Promotion Period is eligible for one entry into the prize draw provided it is submitted on a fully and correctly completed entry form.
3. For the purpose of this promotion, purchases of Westfield gift vouchers, deposits into bank accounts, banking services or payments of bills are not eligible for entry into the draw.
4. Entries must be submitted either a) by completing and submitting the online entry form at www.whatswhat.co.nz or b) on a fully and correctly completed paper entry form (as provided by Westfield to retailers in the applicable participating Westfield centres) and left in the specially marked entry barrels at participating Westfield centres.
