

## TERMS AND CONDITIONS FOR THE WESTFIELD TRINNY & SUSANNAH PROMOTION 2008

2. Each purchase receipt for a single purchase of \$50 or more made in a participating Westfield Centre during the Promotion Period (from all retailers excluding supermarkets) is eligible for one entry into the draw provided it is submitted on a fully and correctly completed entry form.
